Michael Adjemian, President of the Cielo Vista Neighborhood Association, **called the meeting to order at 6:19** and welcomed everyone to our July Zoom meeting. He asked for a moment of silence for those lost to COVID-19 and those suffering now. All participants then introduced themselves.

Major goal when elected was to make the court more efficient. The oldest case he inherited was from 1991, old files have been digitized, Case Cleanup helps deal with oldest cases. He praised his staff. The office has remained open during the pandemic, some have worked from home. They are open from 7 am – 5 pm. All filing documents are on their main website. They treat practitioners (lay people) like clients. There is a positive atmosphere. Taking a twenty-minute break for a walk is accepted practice. He thoroughly responded to all questions.

Karmen M. and Michelle Fenton from El Paso Electric discussed their Summer Intern Corporate Social Responsibility Project that honors the victims and survivors of the August 3rd Walmart Massacre (2019). The interns were not in attendance since it was beyond regular business hours. The interns are thirteen El Paso students who left town to attend college. They are hired by EPE as summer interns. They are partnered with the United Way and Family Resiliency Center for this project. There is an Art project pending for our neighborhood akin to Chalk the Block. The original plan has moved from July 23rd evening to 10:00 or 2:00 that day or possibly another date will be chosen. Mike Adjemian brought up the point that the people in the neighborhood who work will be left out; EPE countered the daytime was better for media.
